Intangible Assets, Compensation and Performance: An Empirical Analysis

Much of the research on intangible assets to-date has been theoretical. The main objective of this paper is to provide a testable conceptual model and some empirical evidence on the association between intangible assets and firm performance. Preliminary results utilizing NFL team performance and compensation data indicate that the group-specific intangible assets are significantly correlated with team performance.
